“HOW TO GET A NEW STREET LIGHT IN RESIDENTIAL AREAS”

In existing residential areas, if you or a group of residents desire to request a new street light be installed on a public street, start by making application to the City of Bonner Springs, Kansas, Attention: Amber McCullough, City Clerk – 205 E. 2nd Street, Bonner Springs, KS 66012.

GENERAL INFORMATION:

Typically, the street light can be installed on an existing electric power pole there will be no cost to residents (except in extenuating circumstances). If the installation requires the installation of a new pole, the costs involved are the responsibility of the resident(s) making the request. This cost generally includes the installation of the pole, wiring, and light. This cost is estimated at \$4,200.00 or more per light requested. If approved, the applicant shall make a check payable to the City. The City will then request the installation by electric power company at the requested location. Installation normally takes 4-6 weeks.

Note: New lights in residential areas require the approval of all residents within a 100 foot radius of the proposed new light location.

PROCEDURES:

1. Talk to neighbors to obtain agreement for installation, complete the **Petition Letter** with sketch/map (attached) and obtain signatures;
2. Submit the completed Petition to the City Clerk, City of Bonner Springs, KS – 205 E. 2nd Street, Bonner Springs, KS 66012;
3. The City Planner will determine if the request meets the City’s Design Criteria, APWA 5800 for Street Lights, at the requested location;
4. If a new pole is required, the City Planner will contact the electric power company to determine the actual cost to install a light at the requested location, and advise the applicant of the cost to install;
5. Once payment is received, the City will verify information and contact the electric power company for the installation; and
6. Once the light is installed, the on-going monthly operating cost of the light is paid by the City.
